CONTRACT BETWEEN THE PARENT /GUARDIAN AND THE SCHOOL.

1. We agree to pay all termly fees in advance. Late payments could result in the cancellation of this application.
2. The principal & aftercare management reserves the right to give 24 hours notice to remove a child from the aftercare facility if :
 - Accounts are in arrears.
 - Behaviour of the learner interferes with the wellbeing of other children or contravenes the code of conduct of the school.
 - The parent is repeatedly late in collecting the child /children (they will be removed from aftercare after 2 late collections.
3. Fees as stipulated are for the current year. Please indicate the time of attendance required.
4. Fees for the school and aftercare are raised annually and appear on one family account.
5. Monies paid will always be credited to school fees first.If you are making monthly payments the monthly amount should cover both the school fees and the aftercare fees.
6. In case of a shortfall school fees will be credited before allocating to aftercare fees.
7. **As this facility is a private independent facility ,the principal/governing body has the right ,if parents default on aftercare payments , to remove the child from the aftercare.**
8. **One full term’s notice is required if,for any reason ,the facility is no longer needed.**
9. Aftercare is a full time service only. Emergency aftercare is offered to non- aftercare children for ONLY two times a month .IT STRICTLY CLOSES AT 17:30pm and not later.

I understand that every reasonable precaution will be taken to ensure safety of my child , and will not hold the school responsible for any unforeseen accident/injury. I understand that I have applied for enrolment for my child to the aftercare center during specific hours and any deviation of the above will be noted .
