In terms of the South African Schools Act, parents are liable to pay the school fees determined in terms of Section 39 by **31 January every year**, unless or to the extent that he or she has been exempted from payment in terms of this Act or alternative payment timelines have been arranged. Any such application must be made on the prescribed form and will be assessed in line with WCED regulations.

It was resolved by parents at our AGM dated 19 October 2020 that **school fees could either be paid in full by 31 January 2021** (in which case R1,000 discount per learner will be applied), or in **full by 28 February 2021** (in which case R600 discount per learner will be applied), OR paid in **equal monthly instalments over 10 months (January 2021 to October 2021)**.

It was further resolved that the SGB could **review the quantum of school fees at a scheduled parent meeting during July 2021 based on the cash position and cashflow forecast** of the school as at 30 June 2021. This assessment will include the extent that expenses budgeted may not be incurred and income budgeted for may not be collected. This may result in either an increase or decrease in school fees.

With the above in mind, please complete the reply slip attached indicating which payment option you prefer and return same to school for the latest by **30 November 2020**. This information is **essential to properly manage the cashflow of the school**.
